## Key topics

Topics covered on the course include:

- purpose and benefits of management systems and the high-level structure of ISO 14001, Annex SL
- requirements of ISO 14001:2015

- continual improvement of the EMS
- identifying environmental aspects and impacts, such as:
  - emissions to air
  - releases to water and land
  - use of raw materials and natural resources
  - use of energy and energy emitted
  - generation of waste
  - use of space
- environmental legislation
